

Everyone should have received the proposed revised Bylaws and Declarations for THPOA. If you have not received them please contact me and one will be sent to you immediately. We had a good meeting with several lot owners on December 3rd and discussed some of the most important changes

in the documents. We will be making a few changes based on the feedback we are getting and a status update highlighting any changes along with a summary explaining some of the most significant changed provisions will be sent out to everyone via email toward the end of the month. The final document to be voted on will be sent out in the first week of January.

Because of the significant changes being made we must have members proactively cast their ballot so that at least 2/3 of our lot owners vote for the revised documents. The reason it is important to vote is because in past elections, the Board assumed the vote for any member that failed to vote, that will not be the case in this election. If passed, the revised documents will not allow Board to assume the vote of any member unless they have a signed proxy. The approval of these two documents are very critical in bringing the balance of decision making power back to lot owners, so please engage and understand the opportunity for property owners to collectively establish the desired standards for this community rather than completely passing that responsibility to the Board members.

More information and explanations will be sent about this in the summary update. In the meantime, if you have any questions or comments please share them with any board member.

Once again the Social Committee will be delivering luminaries to each home. We are asking that we all partake December 31st. in bringing in the new year with hope, prayers and love for 2025!
